

The Community Action Association of Pennsylvania Self-Sufficiency Awards and Annual Conference recognize the significant accomplishments of Self-Sufficiency Award winners while showcasing how Community Action Agencies support a person's journey toward financial stability. Youth Enrichment for Success (YES) program participant Joshua Bower was nominated by STEP, Inc. and was presented with the Self-Sufficiency Award on October 9, 2019.

Josh entered STEP's YES program on August 21, 2018. He worked with a Lead Family Navigator to develop and implement a goal plan which included resume building, improving relationship building skills, graduating high school, employment searching, individual counseling, eliminating involvement with the legal system, continued payment of court fines, and obtaining a Commercial Driver's License (CDL) Permit.

Since enrollment with the YES program, Josh attended school regularly and graduated from Compass Academy on May 30, 2019 and Montgomery Area Junior/Senior High School on May 31, 2019. With the assistance of his Family Navigator, Josh created a resume which he used to obtain employment with Ralph Alberts while still enrolled in school. During this time, he attended counseling appointments, addressed building healthy relationships with peers, and continued to meet with his probation officer regularly.

Josh plans on increasing his hours at Ralph Alberts and completing his CDL Permit in order to enhance his skills through his employer. He looks forward to being involved in the workforce and is eager to learn new skills!

STEP Head Start PBIS Kickoff & Fall Harvest







Two PBIS Kickoff and Fall Harvest events were held in October to celebrate the season!

STEP's Clinton County Community Center welcomed over 160 attendees from Head Start families and the public on October 2, 2019. STEP's Round Hills Campus saw more than 300 Head Start children and families at the event on October 10, 2019.

The events are the yearly kick-off for the Positive Behavior Interventions and Supports (PBIS) program, which teaches children about emotions and coping skills in order to proactively encourage good behavior. Many of the activities, including a PBIS library, pumpkin feeling faces, and calm down bottles, also helped children to practice PBIS strategies. Caregivers are encouraged to carry PBIS into their homes through rewards and various tools.

Other activities included Make a Bee Hat, Pumpkin PlayDoh, Sensory Stations, Make Your Own Beehive, Leaf Rubbing, STEP AmeriCorps Story Corner, Pumpkin Decorating, Face Painting, all while Phoebe, the PBIS mascot, was buzzing around!







During the event at STEP's Round Hills Campus, the community and funders had the opportunity to see two new play areas. The play areas were made possible by a \$108,000 grant from the Williamsport Lycoming Community Fund at the First Community Foundation Partnership of Pennsylvania, combined with Head Start funds.

Both play areas include climbers, water/sand tables, rhythm walls, play houses, and multiple raised garden beds for planting and growing flowers and food. These items provide opportunities for fun and both social and physical development, as they allow play to be combined with learning and growth.















STEP hosted the Color Me Fun Family Run on Saturday, September 14, at the STEP RiverWalk Center. The race was the second major event held in support of the STEP Early Learning Endowment Fund. Jersey Shore State Bank, and McCormick Law Firm. Refreshments for the event were courtesy of Mondelez International, Tebb's Farms and Greenhouses, Lycoming Bakery, Neece Paper, Wal-Mart, Giant, and Wegmans.

STEP AmeriCorps & Central Pennsylvania Food Bank's fifth annual "Glean for Good" was held on Saturday, November 2nd at Carpenter's Pumpkin Farm in Linden. A total of 54 volunteers from STEP AmeriCorps, Central PA Food Bank, Girl Scout Troops 40164 and 40088, Lycoming College, Lock Haven University, Lycoming County United Way, and community members came out to help make gleaning a success.

Volunteers collected 4,487 pounds of pumpkins and squash from the fields that would have otherwise gone to waste. The gleaned produce will be distributed to Central PA Food Bank partner agencies through the Fresh Express program, who in turn will distribute to families in need, along with easy and fun nutritious recipes on how to prepare each kind of squash.
