- VIII. New member orientation: Orientation is on hold till we get more new members
- IX. NEW BUSINESS:
  - **A.** Color me Fun Family Run, 9/14/19. Newberry Subs are doing a fundraiser through sandwich sales for the endowment fund.
  - **B.** Corrective Action Plan: Due on 9/17. The leadership team is still working on the plan, the goal is to have it completed by the end of the week. The plan will be presented to the board on 9/16. We are only to submit what is in place. We looked at our program through a resource based on the Systems Management Wheel and the Five Whys. We looked at onboarding staff, support staff and volunteers. We revamped the process. We looked at our policies and procedures, incident management process, and supervision guidelines (reviewed monthly). Active supervision and universal responsibility will be reviewed at every program area meeting. We put together a training calendar for the year, an observation checklist and are working on a PBIS Matrix for staff. We conducted Implicit Bias Training and using PBIS modules for monthly trainings. We posted the Code of Conduct in strategic places at the sites as a visual reminder. We also put in place staff mental wellness initiatives - Wellness fairs, Brain Breaks, etc. the MH Consultant is available to staff. We also have a Hot Button Activity to help staff recognize their triggers. EHS starts their meetings with a Mindful Minute. Staff and volunteers will be trained, and interview questions will be around the Culture of Safety. WE updated our handbooks and orientation packets. If plan is not approved there would be further consequences.
  - **C. Practiced Based Coaching –** Still looking for a coach. We are looking to use a current staff in the interim.
  - **D.** Early Education Summit If anyone is interested in going, let Carolyn know.
  - **E. Officers** Following elections were made : Marlena Dunn (President)Approved by Aron and Canda. Aron (Treasurer). Canda (Vice President) Approved by Patty and Aron. Canda Board representative, Approved by Patty and Aron.
  - F. PIR The PIR was reviewed. Some highlights 26 Children in EHS considered homeless. 144 Children in EHS were up to date on scheduled age appropriate preventative care, from 12 at the beginning of the year. 167 of enrolled children in EHS had dental care. We are seeing an increase in parents with an advance/baccalaureate degree. For HS, we had 30 children considered homeless. At HS we transported 256 children. HS- 386 children are up to date on preventative primary health care. 105 children were identified as having an IEP.
