- 1. The meeting was called to order at 4:00 p.m. by Chairperson Jeffrey Snyder. On motion of Gail Nestlerode and second by Maria Boileau, the minutes of the October 21, 2019 STEP Board of Directors meeting were approved.
- 2. Patricia Kiessling presented the financial reports for September 2019. On motion of Susan Bigger and second by Regan Garey, the financial reports were approved.
- 3. Rachelle Abbott presented the programmatic reports from October 2019. On motion of Susan Bigger and second by Maria Boileau, the programmatic reports were approved.
- 4. Patricia Kiessling provided information on the following new grants:
 - a. Department of Aging Senior Center Grant for Loyalsock Kitchen (\$50,706); PHARE Countywide Homes in Need for Lycoming County (\$250,000.00); PHARE Supportive Housing Program for Lycoming County (\$245,000); and PHARE Urgent Need Homes in Need for Lycoming County (\$25,000).

The new grants were approved by unanimous consent.

- 5. Jim Plankenhorn provided background information on the STEP Board of Directors Nominee Edward Weinhoffer. On motion of Jack McKernan and second by Gail Nestlerode, Edward Weinhoffer was appointed to the STEP Board of Directors, as a representative of the low income population of Lycoming County.
- 6. Jim Plankenhorn opened discussion on the 2020 STEP Board of Directors Meeting Schedule. With acknowledgement of possible future changes, on motion of Regan Garey and second by Susan Bigger, the schedule was approved.
- 7. David Mitchley provided and update on STEP's Housing Options Pathway. He noted positive changes in workplace atmosphere, employee development, and the integration of the Utilities Assistance Program in the Housing Options Pathway.
- 8. Jim Plankenhorn presented a video on board member duties and responsibilities, "Why Are You Here?" from CAPLAW.
