- **A. Update on Family Pathway Program:** Ruth Love Schooley shared that there are state and federal dollars to provide adult education for people 16 years of age and older to work on their GED and workforce development skills. Ruth is working with Head Start to offer education pieces, specifically under the Head Start umbrella in both Lycoming and Clinton Counties. She is working with all staff to recruit parents to participate in the program. She currently has 7 parents in the program with a goal of 30.
- **B.** Vote of current Policy Council members: Because of this being a transition year with a new director, Carolyn recommended that all current members stay on for a one-year term. This will provide an opportunity to grow the Policy Council and make necessary updates to processes and structure. (Patti W., Amber W.)
- **C.** New Member Orientation in November: Typically, we have held a new member orientation in October. Carolyn would like to have interested parents attend the October meeting then if they are interested in joining have the orientation in November. (Amber W., Malena D.)
- **D. School Readiness Goals:** Laurel Cowher and Julie Shaible presented the School Readiness Goals for 2017. Data is collected in the Fall, Winter and Spring on each child.

It is observation based related to what the child has accomplished and what the child is still working on. The goals are as follows:

- 1. Social emotion
- 2. Physical
- 3. Language and literacy
- 4. Approaches to learning
- 5. Cognitive and general knowledge

The framework to plan for children and their families is based on lesson planning, goals for children, training for staff, learning environments and parent opportunities.

- **E. Health and Safety Screeners:** Health and safety screeners were completed in all of the Head Start facilities. There were no issues found. Once approved by Policy Council, Carolyn will submit a certification signed by the Policy Council Chair and the STEP Board President to the Office of Head Start. (Aron C., Amber W.)
